# Preface

Royal College of Psychiatrist Advance training Curriculum includes Special interest Session.

In the Curriculum It states

'It is educationally desirable that Advanced Trainees in General Psychiatry have the ability to gain additional experiences that may not be available in their clinical placement. Two sessions every week must be devoted during each year from ST4-6 for such personal development, which may be taken in research or to pursue special clinical interests. Special interest sessions are defined as "a clinical or clinically related area of service which cannot be provided within the training post but which is of direct relevance to the prospective career pathway of the trainee". For instance, a special interest session in substance misuse would be of direct relevance to a trainee wishing to subsequently work in an inner city core general psychiatry post. Special interest sessions may also be used for gaining psychotherapy experience that builds upon the experience the trainee had in Core Training. This experience must be appropriately managed, supervised and assessed. The Training Programme Director must prospectively approve the use of special interest time. Special interest and research supervisors must provide reports for the trainee's ARCP as required by the School of Psychiatry."

Same has been recommended for other Speciality training (Older adult, forensic, Learning Disability, CAMHS, Psychotherapy) curriculum .

## **Application and appointment Process**

BSMHFT has number of opportunities to support the trainees in the region. These opportunities are made available for all ST trainees if they wish to participate Trainees are requested to discuss their Special interest session with their Clinical supervisor of Special interest sessions. It is recommended that following discussion trainees can formulate their PDP objective (SMART) and assessment of progression and achievement. That should be discussed with their Educational Supervisor and if necessary TPD.

# According to the Junior Doctor Contract 2016, these Special interest sessions would be part of Personalised work schedule.

If the trainees are employed by another trust but interested to work within BSMHFT for special interest sessions, they need to Contact the PGME manager and HR for an honorary contract. They need to provide evidence of all recruitment clearances, which, must also be signed off by their host employer. See Appendix 1. If trainees are already working within BSMHFT and have moved to Another Trust but would like to continue Special interest sessions within BSMHFT, they can do so as an "Honorary Employee". They are required to register as Honorary Employee with HR/ESR before they move out of BSMHFT. An ESR Honorary form see Appendix 2 must be completed





and signed by their supervising consultant along with a new ICT access form which also must be completed by their supervising consultant

BSMHFT would encourage trainees and Special Interest Clinical supervisors to inform PGME if any trainee and trainer achieve any award, qualification publication etc. for their work with Special Interest session in BSMHFT.

The West HUB CMHT provides psychiatric care through the community for a GP cluster population of over 20,000. It incorporates the suburbs Edgbaston, Harborne, Bartley Green and Quinton.

There is some responsibility for inpatients Ashcroft Complex Care Unit but the work is primarily in the community setting via a combination of outpatient, home visit and general hospital / care home liaison practice which have diminished to a great extent since the introduction of Psychiatric Liaison Teams in acute hospitals. The core trainees have the dedicated office space at the Ashcroft Unit where all the CMHT members of West HUB are based. The core trainees benefits from protected weekly teaching at the Uffculme centre which forms the part of MRCPsych teaching on Thursday mornings followed by Psychotherapy balint groups. We are in the process of designing an in house teaching program as well for all the CMHT members and the core trainees will have opportunity to contribute as well. The weekly trust academic teaching is held on Wednesday mornings at Uffculme centre and contributes to ongoing CPD for both trainees and trainers. The trainee will also benefit from hourly supervision on a weekly basis.

My other role is the Clinical Director for Specialties and Older adult services which involves getting into the management and leadership. This I feel is one of the important areas which is neglected a 'medical professionals'. The trainees will have direct observations of meetings, management of issues and problems, Clinical Governance Committee meetings attendance.

## What Special interests opportunities are available in this post

1. As I hold Honorary posts at the University of Chester and Aston Medical School there will be opportunity for higher trainees to get involved in training and teaching, developing modules for teaching and research activities.

2. I have a wide experience in research and publishing and this would in turn help the core / higher trainees to get involved in research and get it published.

I am based at Reaside Clinic, which is a medium secure inpatient unit for men and provides assessment, treatment and rehabilitation to men with severe mental health problems who have committed a criminal offence or who have shown seriously aggressive or threatening behaviour.

Most of patients come into the service through the criminal justice system, but also from local psychiatric hospitals and high secure hospitals.

The service has community teams of social workers and CPNs that provide follow-up care to patients once they have been discharged from our inpatient units with ongoing follow up from the consultant forensic psychiatrist and medical team. The teams support patients until they are ready to be transferred to the care of a local mental health service such as a community mental health team.

Ardenleigh is the West Midlands regional secure unit for female patients. Patients are referred from across the area for specialist assessment and treatment of complex presentations involving mental disorders and offending or challenging behaviour. There are 30 in-patient beds. Most patients have a diagnosis of a severe mental illness, often associated with treatment resistance. There is a high incidence of personality disorder and co-morbidity. There is also a high rate of serious physical health problems. All patients are detained under the Mental Health Act. Trainees will be able to gain experience in the pharmacotherapy of mental disorders, and a wide range of different psychological therapies with a particular focus on gender-related issues and trauma.

Ardenleigh offers assessments and advice to other mental health services and criminal justice agencies across the region. The consultants all provide a clinical session to a local female prison. The service also provides community support, mainly for restricted hospital order patients who have been discharged from Ardenleigh. The forensic outreach service is currently being expanded and developed.

There are currently three consultant forensic psychiatrists in post – Dr John Croft, Dr Jeremy Rampling and Dr Ruth Scally.

## What Special interests opportunities are available in this post

Special interest sessions will be individualised based upon the timetable of the higher trainee and any specific goals they have. As the patient group is particularly complex with long-term histories and experiences of trauma, trainees will be able to get the best experience if they can commit to attending sessions on a regular basis for at least six months. They will have the opportunity to attend multidisciplinary team meetings; prison clinics; observe and complete under supervision forensic assessments and specialist risk assessments including HCR-20. There is potential to be involved in psychotherapeutic groups, audit and service development projects.

This opportunity is available for higher trainees in any speciality in psychiatry. It would be expected that forensic higher trainees explore the feasibility of a full term placement in the women's service before applying for a special interest session.

## How will achievements be evidenced and evaluated

Workplace based assessments will be completed as appropriate with opportunities to gain case-based discussions, miniACEs and an ACE.



## Psychiatry of Deaf- Deaf Service

## Trainer & Post Information

**Trainer: Dr Steve Carney**, Consultant Psychiatrist - National Deaf Mental Health Service

This is one of 3 national specialised services in the UK for profoundly Deaf adults. The service provides inpatient and community services to one-third of England and South Wales. We are commissioned directly by NHS England.

Our patient population have mental disorders ranging across the field of psychiatry. Our MDT includes Deaf and hearing staff communicating with patients directly in their own language or via interpreters. We have a 12-bed inpatient unit, Jasmine Suite, at the Barberry. We hold regular clinics in Birmingham, Derby, Nottingham and Bath as well as visits elsewhere as needed. We work in support of local teams who must hold care coordination responsibility.

In addition to our day-to-day clinical work we are involved in the Deaf Advisory Group working on national issues such as CQUINs developing a Deaf accessible care plan and a bespoke communication tool.

## What Special interests opportunities are available in this post

This is an opportunity to work in a unique environment. Observing the day to day work of the service across inpatient and community can offer insights into deaf awareness, language, emotional and social development that can be of benefit in returning to work with hearing patients. There is a need to work collaboratively with local services to ensure that as far as possible all needs can be met. This can often involve working creatively, adapting standard assessments and interventions to the clinical, communication and cultural needs of the Deaf person.

It may be possible to attend clinical and management meetings and possibly national meetings with other NHS and 3<sup>rd</sup> sector services. It may be possible to observe NHS England meetings.

There is a limited research base in the field of mental health and deafness and this may be something that can be considered

# There are opportunities to work across all areas of the service with members of the multidisciplinary team.

As noted above we have an experienced multidisciplinary team including 1 Consultant Psychiatrist, 2 clinical psychologists, 1 OT, 2 CPNs, 1 day service manager and inpatient nurses. This includes 1 Deaf Deputy Ward Manager and several Deaf HCAs. The Deaf staff are incredibly valuable and we frequently rely on them more than hearing staff.

## **Psychosis and Rehabilitation**

I have been a Consultant working with patients with Severe and Enduring Mental Illness for 14 years in BSMHFT. I am also the Rehabilitation representative for the Royal College of Psychiatrists West Midlands division and have previous experience of medical management and leadership.

The special interest sessions could be with South Assertive Outreach Team based at Adams Hill and/or the Grove Avenue Psychiatric Rehabilitation Unit in Moseley. These teams serve the South area in Birmingham with a population of 330,000 people.

My AOT works with up to 120 clients with severe and enduring mental illness who have been difficult to engage and have had high use of in-patient services, often with significant risks and frequent co-morbidities.

The Grove Avenue unit works with clients again with SEMI but who have significant impairments in their activities of daily living and disabilities in other areas. There is a mixture of male and female service users and both detained and informal patients are catered for. Grove Avenue is a faster stream service with 10 beds and an expected length of stay of up to 18 months.

Both teams have input from nursing staff, pharmacy, psychology and OT. There is a Social worker and STR workers and a social inclusion co-ordinator within AOT, whilst Grove Avenue utilises SW input from the clients' community teams.

## What Special interests opportunities are available in this post

Higher trainees will be able to spend time with either or both my teams getting practical experience of specialist inpatient Rehabilitation and/or the community and inpatient management of patients under a well-established AOT.

#### How will achievements be evidenced and evaluated
